Our history

State Schools Relief was founded in 1930 during the great depression, by Anton Vroland a Head Teacher from Elsternwick Primary School. On June 12 1930, he organised a meeting with fellow teachers and principals who were concerned about the students living in the barges along the Yarra and huts around the Dudley Flat tip. At the conclusion of this meeting, the State Schools' Relief committee was formed to undertake any relief possible to Victorian students.

The problems of poverty, neglect, family illness, abuse, homelessness and natural disasters continue to affect too many families.

State Schools Relief is unique; no other Australian State has a similar organisation. Our service promotes each child's dignity because the service is run anonymously through the schools.

It would be almost impossible to find a State School, no matter how prosperous, which has not had at least one student who has received assistance from us in the past 84 years. The importance of our work and the thousands of students we help each year ensures that they feel included and valued. It provides everyone, regardless of background, with the opportunity to participate fully in schooling.

Education is the main way out of poverty and this pathway must remain open to every child.

President

Planning our future has continued to be the key function of the Board of SSR Inc during the last 12 months.

Deloitte delivered their report towards the end of 2013 giving the Board clear focus on our core purpose of enabling disadvantaged students to participate in school while meeting the twin challenges of increased demand from schools and the need for constant fundraising to meet that demand.

The Report provided recommendations on both our governance and our business model. With respect to governance the Board moved quickly to implement the recommendations which now means we have four Board meetings a year, a much enhanced subcommittee system and a more pro active executive.

Our Audit Risk and Compliance has provided a major input into SSR work and we now have a comprehensive risk management system and appropriate checks and balances to enable good financial management.

The Marketing and Fundraising Committee is a springboard of creativity around fundraising and is currently developing a marketing plan which will incorporate community and corporate fundraising ideas and activity while the Rules committee has been instrumental in our modernising process.

The executive now meets monthly and is responsible for the governance of SSR between Board meetings and is the channel of communication between the sub committees and the Board.

Reviewing our business model was a major Deloitte recommendation and in the context of the abolition next year of the Education Maintenance Allowance and proposed reductions in federal government support programs we are working to ensure that we have a sustainable business model which will meet the likely increased demand flowing from government program changes. This will involve a review of the co payment system, an examination of our major users and the



services they require and how this service could be delivered in a more efficient effective and equitable manner.

One of the most critical tasks entrusted to a Board is the selection of a Chief Executive Officer and this year due to the retirement of David Schmidt we have been through that process to appoint Stephen Iles who commenced work in early May. Stephen brings much skill and expertise to the role with a background in investment banking and as a CEO of not for profit organisations.

I would like to pay tribute to the work of our former CEO David Schmidt. David retired at the end of February after seven years in the positions and before that many years of involvement as a Board member. David is passionate and enthusiastic about the work of SSR and the difference it makes to enable kids to participate in schools. For many in the education community David was the heart and soul of SSR. He will be greatly missed.

The Board has also had a number of changes this year with the resignation of Susan O'Leary from Parents Victoria, Carol Kelly from DEECD and Pitsa Binnion representing secondary Principals. I thank them all for their work and their commitment to SSR.

We also welcomed on to the Board Kate Fenby and Keri Langes. Both Kate and Keri have been co-opted for their marketing expertise and Kate has taken on the role as chair of the marketing committee.

I would like to thank all my fellow Board members for their contribution and particularly thank subcommittee chairs Rommie Redlich – Audit, Risk and Compliance, Kate Fenby Marketing and Fundraising and Ralph Francione Rules. Thanks also Christine Stewart, Deputy President and Tony Ross Treasurer.

The staff of SSR have continued to provide exemplary customer service to schools, sponsors and the wider community and this year have successfully implemented the long planned for on line ordering system. I would particularly like to thank Val Marshall for her

leadership and guidance while she was acting CEO.

SSR Inc cannot exist without the support we receive from DEECD and from our sponsors, most notably The Australian Schools' Canteen Association, bankmecu and Victoria Teachers Mutual Bank. Community fundraising, mainly through schools, is also critical to determining the levels of support we can give back to schools and students and I thank all donors to the SSR cause and as we proudly say every dollar donated goes back to supporting a student attend school

The SSR Board is well into the process of renewal in the transition to a modern organization operating in an environment where we recognise and mitigate our risks to ensure our ongoing and effective delivery of support to the many thousands of Victorian students attending state school who avail themselves of our services

Chief Executive

Since commencing in May 2014, I am aware of the tremendous support enjoyed by SSR from a wide range of essential stakeholders. Without their continued interest and commitment to tackling disadvantage, the work of State Schools' Relief (SSR) would simply not be possible. I would like to formally acknowledge this commitment.

School communities

I have been impressed and humbled by the outstanding regard and consequent support for SSR in school communities. The continued fundraising for disadvantaged students in schools is of particular note. Established by principals and teachers, SSR continues to be sustained by Victorian educators. The balanced model of fundraising and relief assessment and distribution continues to serve disadvantaged children 84 years later. I cannot underestimate the critical role that school business managers play in collecting, counting and remitting the \$250,000 raised each year by Victorian schools.

Staff and volunteers

I am especially thankful for the support and dedication of SSR staff, in particular Val Marshall, Pam Williams, Lyndelle Everitt and Andrea Travers. The implementation of the online application database has been a major achievement. They have supported the organisation's work during a period of organisational change with professionalism.

Board

Since commencing in May the board has given me great support. I am particularly appreciative of the time each member has given, as I commence in the role.

Partners

SSR relies on a committed group of sponsors and donors to maintain our work. The Department of Education and Early Childhood Development (DEECD) and bankmecu are tremendous sponsors. While Australian School

Canteens Association and Victorian Teachers Mutual Bank are fantastic impact donors.

The support of the Australian Education Union, Victorian Principals' Association and Victorian Association of State Secondary Principals all are essential in the work of SSR.

Challenges

The coming 2015 school year presents SSR with new challenges. The impact of the Gonski funding reforms in Victoria will be an enormous challenge. As part of these reforms the allocation methodology of supporting disadvantage will shift from supporting individual families to distributing funding to schools based on socio economic need. This change will have practical effect with the withdrawal of the Education Maintenance Allowance (EMA). This payment was made to low income households with children enrolled at school. Seventy percent of parents elected, on average to assign these monies direct to the school to pay for essential education items. This ensured that approximately 97,000 state school children from low income families commenced the year in credit with the school.

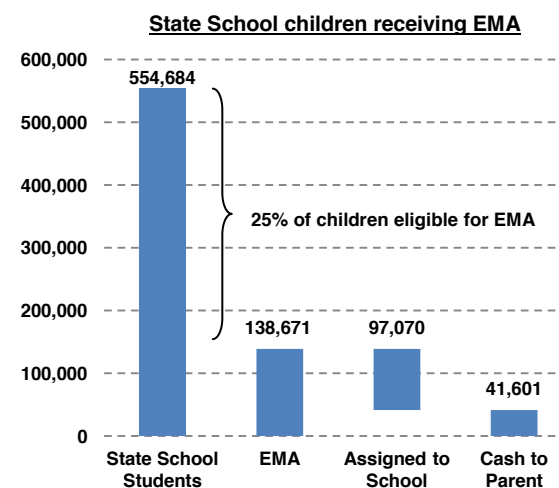


Figure 1: Education Maintenance Allowance recipients by disbursement type (2013 SSR analysis)

SSR expects that many of these children will be reliant on SSR in 2015 for clothing and footwear as a result.

Year in review

SSR has experienced increased demand for its services during the year. Additionally the cost of these services has also risen.

Need

Eighty percent of disadvantaged Victorian children attend government schools. This is entirely consistent with the wider Australian experience.

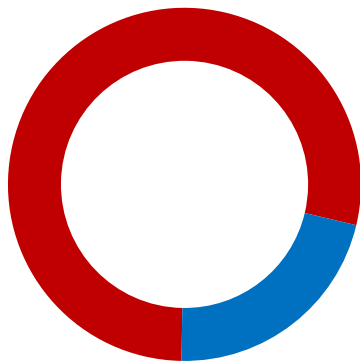


Figure 2 : Proportion of disadvantaged children attending Victorian state schools

Assistance

During the 2013-14 financial year SSR received almost 10,000 applications for 42,000 items from Victorian state schools on behalf of disadvantaged children. This represented an 18 percent increase on the previous year.

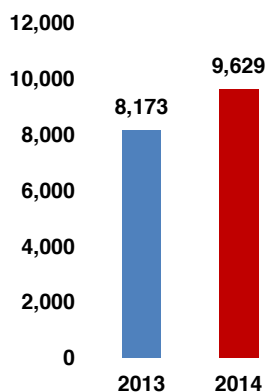


Figure 3 : Number of applications to SSR by year

2013-14 witnessed a 61 percent increase in the cost to SSR to service the 18 percent increase in demand.

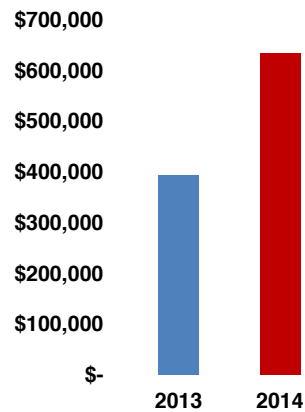


Figure 4 : Cost of clothing and footwear to SSR per year

This growth in cost has been driven by three primary factors.

Over time the amount of unbranded clothing in school uniforms has diminished. Branded items are naturally more expensive. Overtime the value of unbranded items SSR is able to distribute has declined.

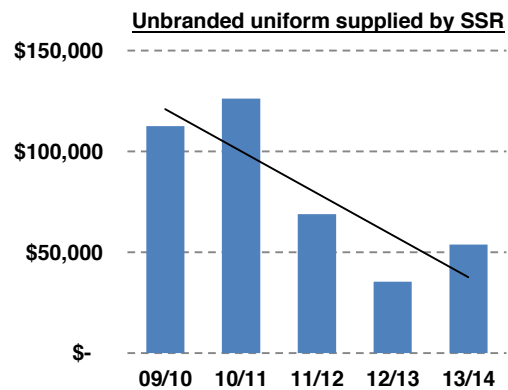


Figure 5 : Value of unbranded uniform to SSR by year

Changes in labour market participation make it difficult for schools to run uniform shops.

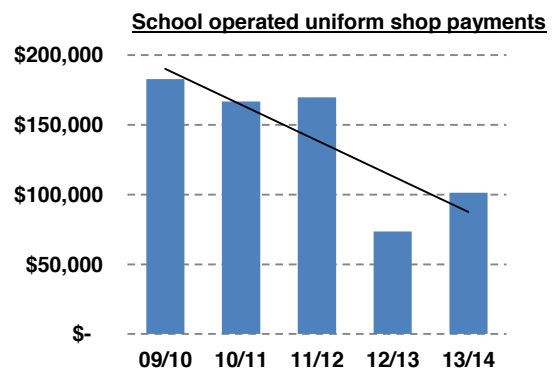


Figure 6 : Value of SSR payments to school operated uniform shops by year

Fact > Every dollar donated to SSR only funds clothing and footwear

School run uniform shops relied on volunteers and free premises with proceeds topping up school funds.

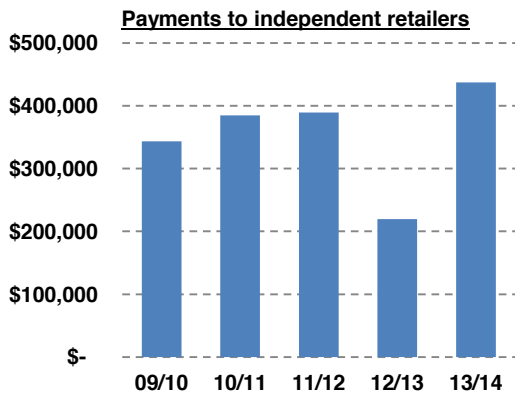


Figure 7 : SSR payments to third party uniform suppliers by year

Now with volunteers hard to source and schools lacking the working capital to carry large stock holdings, payments to third party uniform suppliers have grown.

Fundraising

Schools

School based fundraising continues to increase year on year. The commitment of individual school communities to hold fundraising events is outstanding. A list on individual donor schools appear later in this report in order of receipt of funds throughout the year.

In 2013-14 school based fundraising reached \$268,000. These funds were raised by 425 individual schools.

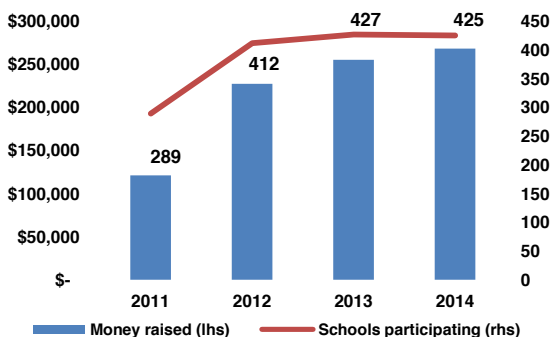


Figure 8 : Money raised against number of schools participating in fundraising by year

School fundraising in primary schools continues to be stable year on year.

Secondary school fundraising has grown strongly. The impact of P-12 composite schools has declined over the year.

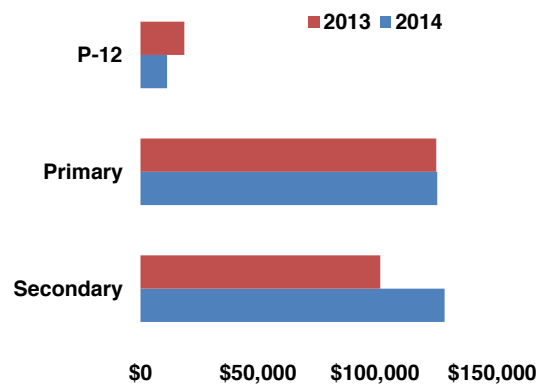


Figure 9 : Fundraising by school type by year

Payroll giving

Each year almost 500 DEECD staff salary sacrifice a fortnightly donation through the payroll system. Staff received their tax deduction up front each fortnight.

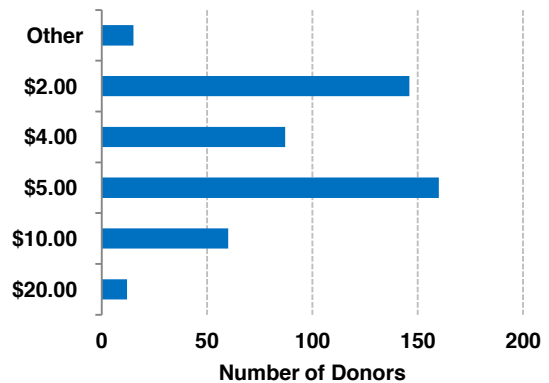


Figure 10 : Payroll giving by fortnightly donation amount (May 2014)

Corporate support

For each dollar raised by schools SSR seeks to at least match that dollar with another from other sources, in particular the corporate sector.

A small reduction in corporate support was recorded during 2013-14 owing to a realignment of the funding priorities of ASCA. A renewed focus on widening the fund raising of SSR is a priority for 2015.



Place-based philanthropy

A place-based approach to SSR's engagement with the philanthropic community has been enhanced with the deployment of the online application database during the year. SSR is now able to warrant to donors where their money has been spent. This is particularly important to funds and trusts with specific geographic interests.

The Riddiford Trust

The Riddiford Trust and State Schools' Relief together allocate much needed funds to 12 schools in the Traralgon district. The funds assist students from disadvantaged backgrounds to fully participate in schooling.

History

The Riddiford Trust was established in 2009 to manage a legacy left by Jack and Margaret Riddiford, who were residents of Traralgon for more than 40 years.

Jack established Riddiford's Pharmacy and Camera Store on Franklin Street and ran the business for many years until retiring in the early 1970's. This building has been occupied since then by various pharmacies and is currently occupied by Chemist Warehouse.

Jack was very prominent in Traralgon public life, being a Justice of the Peace, President of Traralgon Rotary and President of the Traralgon Club.

In his life Jack was a leader and an innovator taking a leading role in the development of chemist and camera store co-operatives or buying groups in Victoria, which are now an established part of those industries. He was also involved as an investor in many new start-up business ventures in Traralgon and was always keen to encourage people who had an idea and the initiative to make it work.

During their life, Jack and Margaret were interested in helping young people to develop their potential if they showed some promise and they quietly did this on many occasions.

On their death, the family decided to establish The Riddiford Trust to remember Jack and Margaret and to continue their support for young people with potential, to encourage them to achieve their personal ambitions and make a contribution to their communities.

Program

Schools make applications on behalf of students for costs of schooling other than footwear and clothing. This year almost \$20,000 was provided, covering such things as camps, schools excursions, and specialised equipment to eleven schools in the Traralgon region.

The Riddiford Trust also supports the *Hands on Learning Project* at Traralgon Secondary College having provided an initial \$5,000 grant in 2014 and a further \$5,000 for 2015.

Additionally, ten \$500 bursaries are awarded to worthy Year 9 & 10 students who are undertaking main stream subjects at Traralgon Secondary College, to provide learning opportunities that would not otherwise be available to them.

Myrtle Crook Scholarship

In October 1966 the estate of Sydney solicitor Mr. Alan Crook endowed an annual prize, "to be awarded at the discretion of the Committee". The money was invested and the annual interest was directed to an annual prize known as the Myrtle Crook prize, to be awarded to an ex-grade 6 pupil considered by the Committee to merit assistance because of his or her needs and academic progress. The interest was to be paid annually to the head master of the post-primary school which this pupil advanced to, and its wise utilisation was the headmaster's responsibility.

The first winner of this prize was Jutta Schafer - a pupil of Cremorne Street State School (now Richmond Primary School) who went on to Richmond High School.

The prize has been awarded each since to a Richmond Primary School student who meets the criteria.

Innovation

SSR is principally concerned with tackling disadvantage to ensure that disadvantaged children have the capacity to engage in educational opportunities. This interest extends beyond clothing and footwear.

Vision care

Onesight and State Schools Relief conducted an initial pilot program in four Victorian government schools over the past 12 months. The program seeks to screen every child in years Prep to Grade 3 at each school over two days with the purpose of providing free screenings, including providing vouchers for free glasses to disadvantaged children.

Need

Many disadvantaged children do not have effective access to optical services. Refugees may not have access to Medicare funded eye testing while many families avoid the optometrist knowing they don't have the money for glasses if required.

School clinics

Volunteer staff from OPSM, Sunglass Hut and Laubman & Pank stores conduct individual student screenings. Students are screened for colour vision, depth perception, distance vision and near vision. Each assessment clinic is staffed by a number of optometrists who are also able to assess binocular vision and observe general eye health.

Students who require eye tests and possible treatment are issued with a voucher redeemable at the local OPSM or Laubman & Pank outlet. Each voucher provides the referred child with a free pair of frames and lenses should they be required.

About Onesight

Onesight is a charity that conducts vision care programs in the community at no cost. Since 1988 these charitable efforts have provided free vision care and eyewear to more than 8,000,000 people in need around the world and have granted millions of dollars toward

research and education. Their programs are only possible because of the generosity of volunteers who donate their time.

Future plans

SSR and Onesight are currently reviewing the pilot outcomes. Once complete, the review will inform how this valuable and highly practical measure can improve and extend the education careers of disadvantaged children in state schools

School milk – from the archive

State Schools' Relief instituted school based distribution of milk in state schools because of concerns about the impact of hunger on learning in the classroom. Many Victorians have strong memories of drinking milk each day. This was a forerunner of modern day school breakfast programs.

The 1934 annual report records that 32,030 gallons of milk were supplied to 115 schools by 20 contracting firms. This continued throughout the Second World War with a grant of 1,350 pounds being made by 1941 to fund the program. At its peak 42,173 gallons of milk were distributed. A proposal made by the Federal Government that free milk be provided to all school pupils under 12 was finally introduced on 17th September 1951

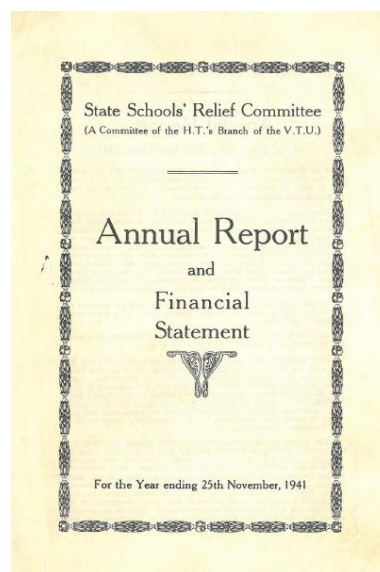

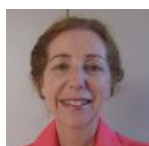
Tony Ross – Treasurer – elected
